Pricing:

All prices are subject to change without notice. Please call a JM Auto Racing sales representative to confirm pricing and product availability.

Sales Buy in Program:

In order to receive the best rates possible we require an initial buy in of at least \$1000. This buy in does not include shipping costs. Once the initial buy in is met, you are required to keep a least a \$500 sales minimum per month. Special exceptions will not be made unless agreed upon prior to this contract. Terms:

New account payment terms are established based on furnished customer information requested by JM Auto Racing (see new account application package for details), and the customer's credit rating. JM Auto Racing will assess a finance charge of 1.5% per month on any past due account balance. A service charge of \$25.00 will be applied to each returned check. Delinquent accounts are subject to penalty allowed by the NYS Law (Chapter 522 Sec.1719) and other related legal and collection costs.

Shipping:

Freight prepaid by JM Auto Racing applies to orders with minimum amount of \$3,000.00 or more, Canadian customer's minimum amount is CA\$5,000.00 to qualify.

Sample Request:

Samples are available upon request and is subject to fees allowed by laws wherever is applicable.

Return Policy

Return Authorization:

All return of JM Auto Racing products must obtain Merchandise Return Authorization from a JM Auto Racing sales representative, or, a Customer Services, prior to sending products back to JM Auto Racing.

Customers intend to return products purchased from JM Auto Racing and not in the nature of defective or shipped-in-error, the returning product must be in its original packaging and are in saleable condition, without any components missing, before process for MRA, and are subject to 20% Restocking Charges. The returning party is responsible for the freight charges.

Product return freight charges is the responsibility of the returning party and it must be prepaid, except the returns with pre-arrangement by JM Auto Racing to provide UPS Call tag or truck pick up with freight collect. All returns must ship to a JM Auto Racing branch close to the returning party.

JM Auto Racing will reimburse freight cost to the prepaid returning party upon verifies the reason for return is justified with proper cause.

Shortage or Shipped-in-error Claims

Claims must be made within 7 days upon receipt of goods; claiming party must contact JM Auto Racing at (516) 287-8552

The following information is required to process your claims.

- **For shortage claims:**

1. JM Auto Racing Invoice Numbers
2. Manufacturer Part Numbers
3. Quantities returning
4. Copy of an original shipment signed freight bill

- **For Shipped-in-error items:** (customer intend to keep)

1. Invoice Numbers
2. Manufacturers Part Numbers & Quantity (item not receive)
3. Manufacturers Part Numbers & Quantity (error items received)

- **For Shipped-in-error items:** (customer intend to return)

1. Fill out Merchandise Return Authorization Form, MRA Form can be obtained by contact JM Auto Racing at (516) 287-8552
2. Fax completed MRA Form to JM Auto Racing at 631-587-8848 for return authorization.

Damaged or Defective Returns

1. Fill out MRA Form
2. Fax MRA Form to JM Auto Racing at 631-587-8848 for return authorization.

Sending products back to JM Auto Racing

JM Auto Racing must receive authorized return items within 30 days after the date return authorization is issued.

Products returned due to shipping error or customer's overstock must be in its original cartons and in re-saleable condition without marking or writing on carton.

Note: Return items will not be accepted due to unauthorized returns, misused, abused or improper installation.

Warranty Notice
